## DESCRIPTION

Comprising a useful block of 29.7 Acres [12 Hectares] meadow and pastureland. The land has the benefit of roadside access mains and natural water supplies.

The land is made up of two sperate enclosures for agricultural purposes and is classified as Grade 4 on DEFRA's land classification maps. The roadside boundaries are stockproof comprising estate fencing, post and wire fencing and mature hedges. The land is bordered by mainly mature woodland with post and wire fencing.

Offering a combination of natural beauty, privacy, and commercial viability, this is a rare find for those with interests in farming, forestry, recreation, and conservation.


The land presents substantial potential for grazing livestock or generating revenue through avenues such as natural capital, including biodiversity net gain and participation in the carbon market.
