This top floor flat offers a spacious living accommodation which is benefits from having a good sized driveway and large enclosed south facing garden. The property is close to the town centre, train station and local schools. The property is ideal for the first time buyer or someone looking to downsize. Viewing is highly recommended.



In detail, the property comprises of an entrance hallway with stairs leading to the upper hallway which provides access to all the apartments. To the front of the property you will find a large bright living room with views across Ardmillan Road. Adjacent to the living room you will find a good size kitchen diner. The fitted kitchen can be found at the rear of the property with an array of base/wall mounted units with co-ordinating worktops over tiled splash backs, inset stainless bowl sink, standalone cooker and space for an under the counter fridge and freezer.

The first of the double bedrooms can be found to the front of the property and features a window overlooking Ardmillan Road. The second double bedroom features a built-in wardrobe and can be found to the rear with views across the rear garden. Completing the accommodation is the bathroom room complete with wc, wash hand basin, bath and over bath shower.

The rear garden is split into two sections, the front of the garden has two lawns with a paved path and the rear of the garden is chipped with borders.

Other features of this property include a driveway with space for 2 cars.

Girvan has good local amenities including primary and secondary schooling, restaurants and shops. The world famous Turnberry golf course is only a short distance away and South Ayrshire has long been recognised as a golfing mecca. There is also a rail link to Ayr and Glasgow.
















GROUND FLOOR


