



Description

A large detached four/five bedroom bungalow set within level gardens in an idyllic countryside location. The property is in close proximity to the north Somerset coast and Quantock Hills and offered in excellent order throughout. It benefits from double glazing and LPG gas fired central heating.

THE PROPERTY:

The accommodation comprises a porch/utility area which opens into the kitchen/dining room with windows to the side and a range of base and wall cupboards finished in pastel green, contrasting worktops incorporating a breakfast bar area and space for various domestic appliances. Alongside is a dining area with space for a table and chairs. The living room is dual aspect with a bay window which overlooks the front garden and a fireplace on the wall opposite. There are four/five bedrooms as well as a bathroom and shower room and cubicle off one of the bedrooms. One of the bedrooms is currently being used as study.

The bungalow overlooks delightful gardens at both the front and rear and includes an array of off-road parking as well as a home office/summerhouse measuring 16'5" x 13'1" (5.00m x 4.00m) and a double garage. The gardens are easily managed although they are of a generous size comprising predominantly lawn with flower and shrub beds.

LOCATION: The property is positioned in the Somerset village of Stogursey, close to the Quantock Hills an Area of Outstanding Natural Beauty. Stogursey enjoys a parish church, primary school, village shop, castle and a public house. Nether Stowey is a friendly Quantock Village and has general stores, post office, butcher, pubs, a restaurant, vet, library, GP practice, St Mary's Church and a primary school. The playing field within the village is thriving and used by a number of organised groups and dog walkers. Plans for a new community centre on the field are well advanced. The area offers opportunity for many rural activities including golf at Cannington 18-hole golf course and Enmore Park 18-hole Golf Club, fly fishing at Hawkridge Reservoir and sailing at Durleigh Reservoir, also many beautiful walks on the Quantock Hills itself. Bridgwater is 9 miles away and Taunton 10 miles, both offering higher educational facilities, leisure and retail amenities. Main line links are available via Bridgwater and Taunton railway stations. Access to the M5 motorway can be gained via junction 23 and 24 at Bridgwater or 25 at Taunton.
