

Description

Withygrove Close is a three bedroom semi-detached property situated in a quiet cul-de-sac with potential, with the right planning conditions, to extend to the side or the rear.

THE PROPERTY:

The accommodation comprises an entrance porch, an entrance hall, living room, kitchen/breakfast room and conservatory.

To the first floor there are three bedrooms and a family bathroom.

Outside – To the front of the house is a lawned garden and off-road parking for two vehicles. The garden to the rear is fully enclosed with a pleasant, decked area ideal for sitting out with friends.

LOCATION:

The property is situated on the east side of Bridgwater with convenient access to junction 23 of the M5 motorway without passing through the town. The Bower Manor development offers shops for day to day needs and there is a regular bus service to the town centre. Bridgwater College, offering higher education, is close by. The recently built Bridgwater Hospital is located a short walk away. The property is situated approximately 1.5 miles from the town centre that offers an excellent range of facilities including retail, educational and leisure amenities. Main line links are available via Bridgwater Railway Station. Bridgwater offers a daily coach service to London together with a regular bus service to Taunton, Weston-super-Mare and Burnham-on-Sea.
