




Description

The property is a two bedroom end of property in the popular Bower Manor development and benefits from off-road parking.

THE PROPERTY:

Claremont Grove is a two bedroom end of terrace property which is very stylishly presented with a living room, kitchen/breakfast room and to the first floor are two bedrooms and a family bathroom.

To the front of the garden is off-road parking for a number of vehicles giving side access to the rear garden.

With it being an end terrace you have an extra bit of garden with a patio area and lawn.

LOCATION:

The property is situated on the east side of Bridgwater with good access to junction 23 of the M5 motorway without passing through the town. The Bower Manor development offers shops for day to day needs and there is a regular bus service to the town centre. Bridgwater College, offering higher education facilities, is close by and Bridgwater Hospital is located a short walk away. The property is situated approximately 1.5 miles from the town centre that offers an excellent range of facilities including retail, educational and leisure amenities. Main line links are available via Bridgwater Railway Station. Bridgwater offers a daily coach service to London together with a regular bus service to Taunton, Weston-super-Mare and Burnham-on-Sea.
