

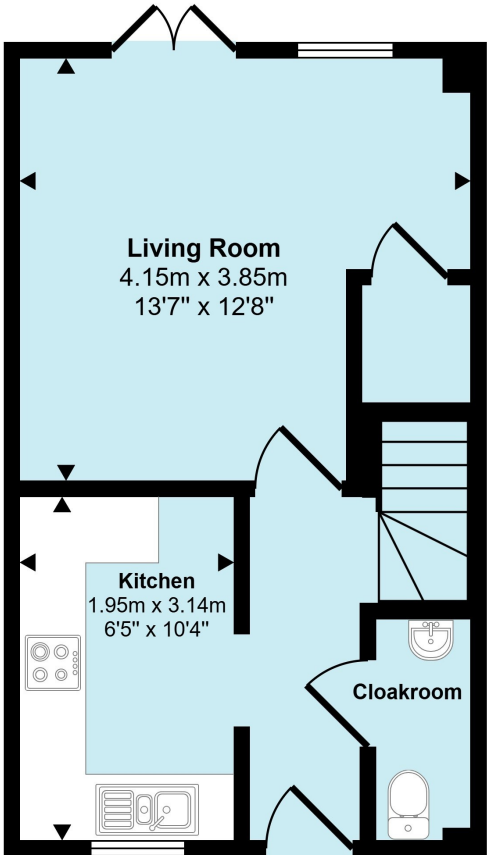

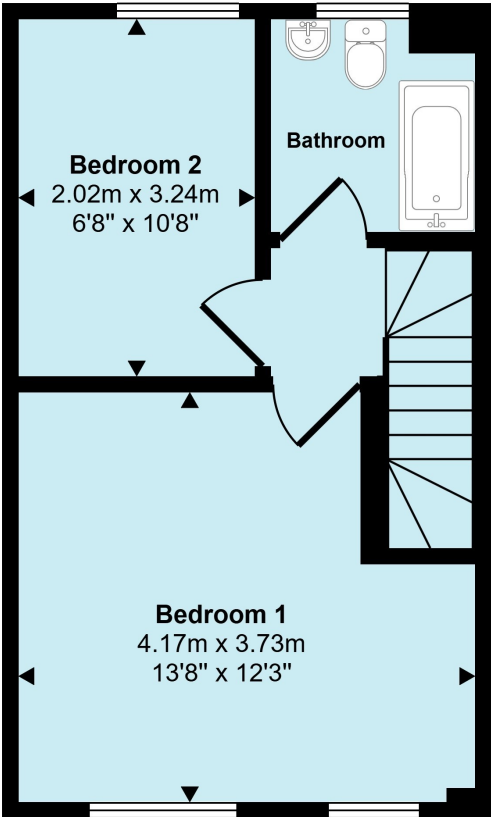

# Description

Daisy Close is a two bedroom semi-detached property situated in Wilstock Village on the edge of the development with beautiful views across towards North Petherton.

The property is offered to the market with no onward chain.

**THE PROPERTY:**  
The accommodation comprises an entrance hall, cloakroom, a modern kitchen, a living room and to the first floor there are two double bedrooms with the principal bedroom - big enough to put in an en-suite - and a family bathroom.

Outside - To the front of the house is off-road parking under a car port which leads to the garage with an electric roller shutter door and its own electrical supply.

There are electric points at the front and rear of the house and an outside tap. A verandah is on the back of the house.

The garden to the rear is designed with low maintenance in mind and is fully enclosed with a large fishpond, a patio area and storage sheds which also have their own electricity supply.

A viewing of the dwelling comes highly recommended not only to appreciate its situation and views of the development but also the living accommodation it offers.

**LOCATION:**  
Situated on the popular Wilstock Village with a rural feel yet close to services and facilities the town has to offer. Positioned in the parish of North Petherton which is approximately 1½ miles away with range of shops and facilities including primary school, GP and pharmacy. Bridgwater is 2 miles distance and offers a wide range of leisure, educational and retail facilities. There are main line links via Bridgwater Railway station. Regular bus services run to Taunton, Burnham-on-Sea and Weston-super-Mare plus a daily coach service to London Hammersmith from Bridgwater bus station. The M5 junction 24 is easily accessed from the development.
