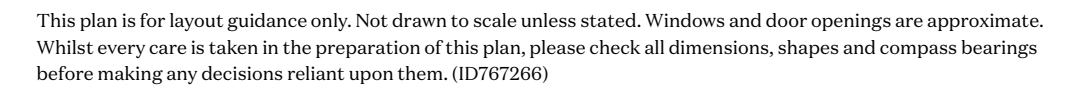
## THE PROPERTY

The generous and flexible layout includes six bedrooms, six bathrooms, and three reception rooms—one being a cosy living room with a feature fireplace and doors opening to the rear garden.
