







Sighthill is a popular residential district to the west of the city centre. There is a good range of local shops and amenities at Sighthill Shopping Centre close by, with further facilities available at Hermiston Gait and The Gyle Shopping Centre. Excellent leisure facilities are available at the West Side Plaza, including a multi-screen cinema. Schooling is well represented from nursery to senior level, with Napier University and Edinburgh College Sighthill Campus both nearby. The property is also well-placed for Edinburgh Business Park and the Royal Bank headquarters at Gogarburn, as well as Sighthill Recycling Centre and both Bankhill and Sighthill Industrial Estates with their numerous small businesses springing up.
