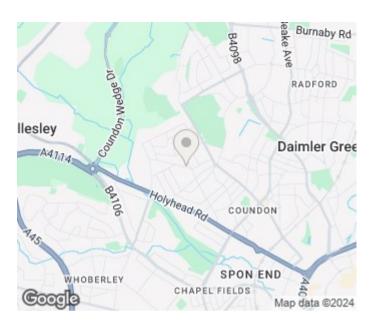


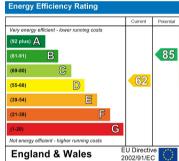


Ground Floor
