With double glazed window to the front elevation, stairs to first floor, laminate floor, radiator.

L-Shaped Lounge Diner 19' 2" x 16' 10" (5.85m x 5.12m)

Measurement narrowing to 3.29 m. With double glazed French doors to the rear elevation, double glazed window to the rear elevation, laminate floor, gas fire with surround and hearth, two radiators.

Kitchen 11' 9" x 7' 11" (3.58m x 2.41m)

With double glazed window to the side elevation, double glazed door to the side elevation, laminate floor, sink and drainer unit, wall and base units with work surface over, integrated double oven and microwave, inset hob with filter hood over, integrated dishwasher, integrated washing machine, integrated dryer, two storage cupboards.

With double glazed window to the rear elevation, laminate floor, radiator.

Bathroom 8' 11" x 5' 4" (2.72m x 1.62m)

With double glazed window to the side elevation, tiled floor, tiled walls, bath with shower over, low-level WC, wash hand basin with storage below, LED mirror over, ladder towel rail/radiator.

A good sized tiered rear garden with decked area, gravelled area, steps leading to paved patio seating area, lawn, flowerbeds and shrubs.




