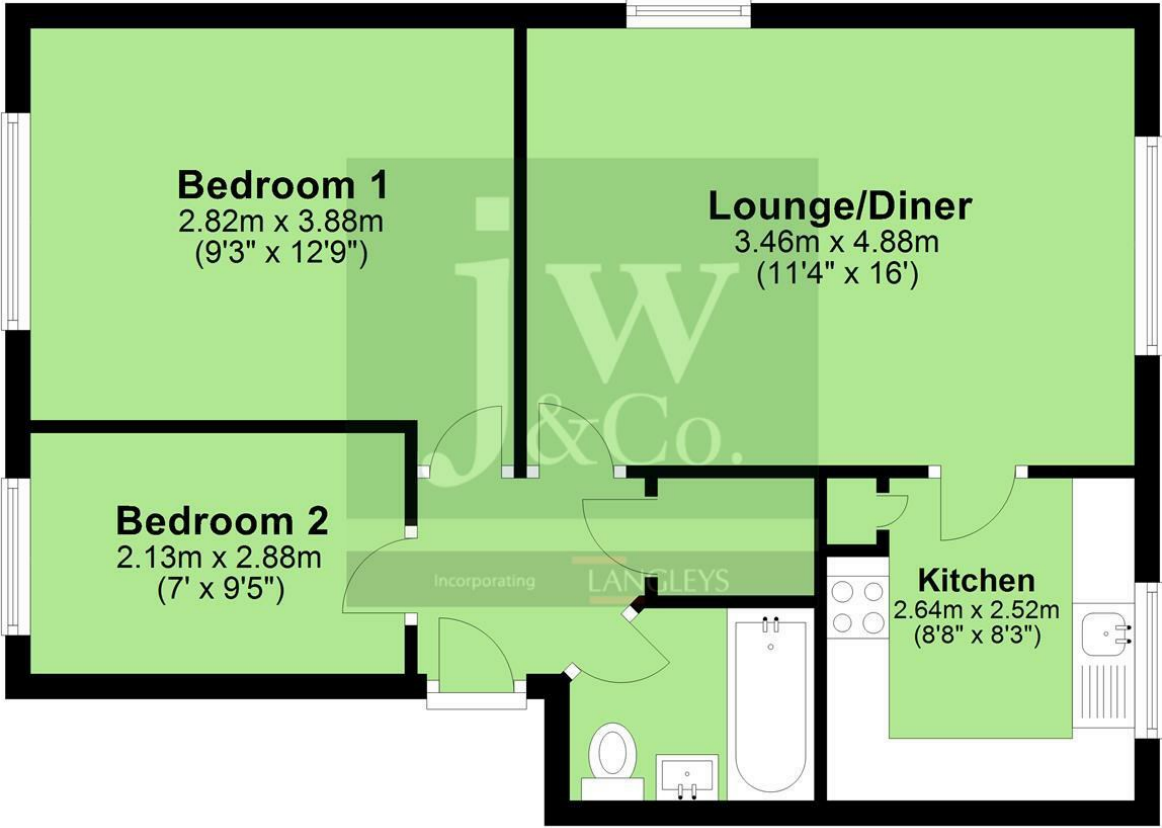


First Floor
