


## **DESCRIPTION:**

This detached house occupies a corner plot in a private driveway of only three properties in a sought after location close to Rooksbury Mill Lakes. The well presented accommodation comprises hallway, sitting room, kitchen/dining room, conservatory, ground floor shower room, four bedrooms and a bathroom. To the front there is generous driveway parking leading to a garage whilst a particular feature of the property is the good sized and well tended garden which extends to two sides of the property.
