Two windows to front aspect, gas fire and radiator.

Window to rear aspect and radiator.

Bathroom

9'6" x 6'5" (2.9m x 2m)

Window to rear aspect and fitted with panel bath with electric shower over, wash hand basin, low level WC and radiator.

Outside

To the rear of the property there is an enclosed patio garden.
