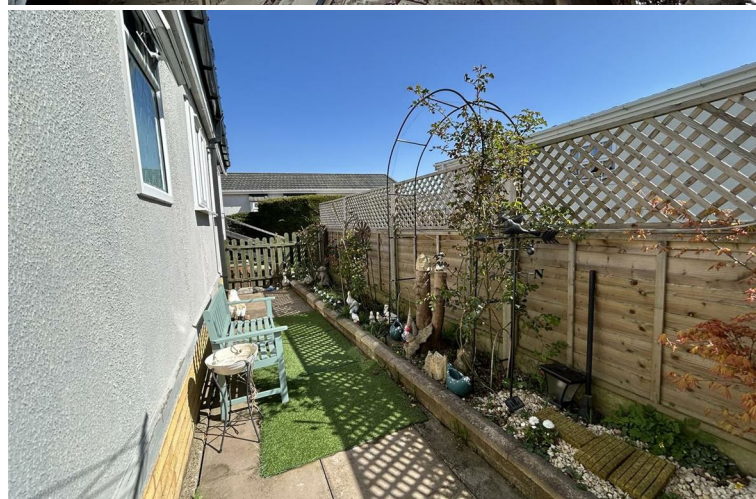
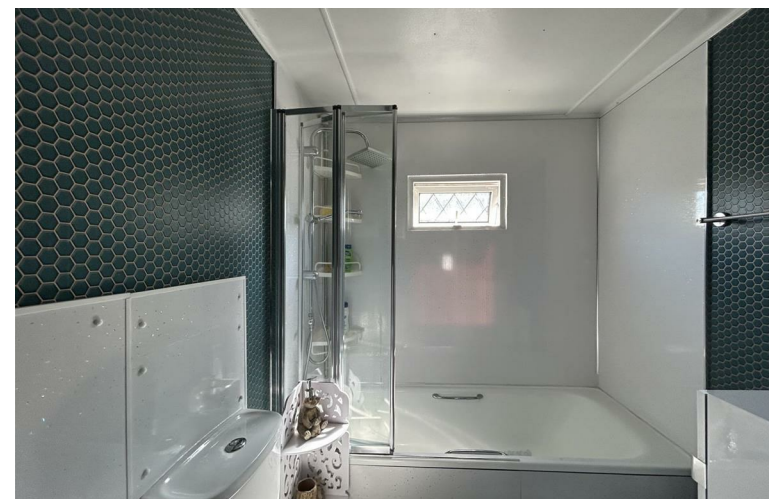

TENURE: The property is not freehold it has no title and is classed as a chattell. we are advsied the monthly site fee is £199.46.

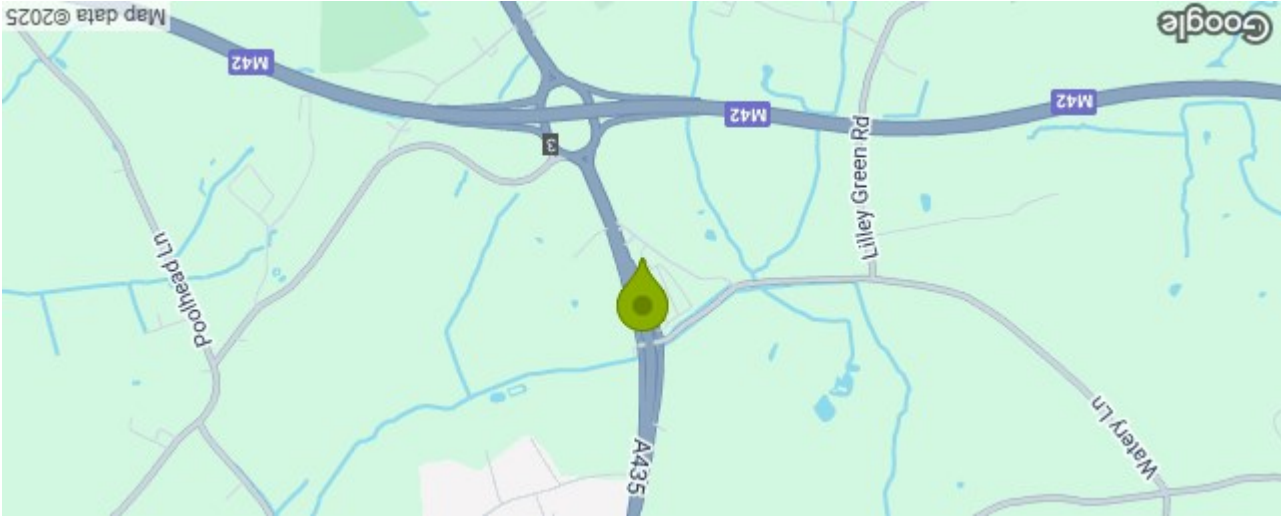
