

An ideal location for this detached family home which has been superbly maintained and presented by the current owners close to the local amenities of Hollywood and Wythall.

Local schooling can be found within walking distance at Coppice Primary school and Woodrush Academy on nearby Shawhurst Lane. Education facilities are subject to confirmation from the Education Department.

There is the benefit of local shops on May Lane, Drakes Cross parade and Alcester Road in Hollywood. The property is just a few minutes drive or by bus to Shirley along Truemans Heath Lane and one can continue back through Hollywood to Sainsbury's at the Maypole island, which also provides access to Birmingham city centre and the southern Birmingham suburbs, along with the Hollywood by-pass which links to the M42, forming the hub of the midlands motorway network.

There are railway stations close by in Wythall and Whitlocks End offering commuter services between Birmingham and Stratford upon Avon, and local bus services provide access to the City of Birmingham, Redditch, Solihull and the surrounding suburbs.

Set back from the road via a tarmacadam driveway with coniferous screening, a UPVC front door opens into the welcoming hallway with stairs rising to the first floor accommodation, guest cloaks WC, garage and superb extended and refitted kitchen diner with a comprehensive range of integrated appliances, vaulted ceiling and UPVC double glazed double doors to the rear garden.

The dining room has double doors into the spacious dual aspect lounge with sliding patio style doors into the conservatory.

On the first floor the master bedroom suite comprises of a dual aspect bedroom and refitted en suite shower room, there are three further double bedrooms and a refitted family bathroom.

The side garage has an electric roller shutter door to the front driveway and courtesy side door to the rear garden which a most attractive element of this property with a private out look having paved patio area leading to shaped lawn with raised edged flower, shrub and herbaceous borders, fencing to boundaries, coniferous screening and gated side access.
