An ideal cul de sac location in this popular and sought after development in the heart of Alvechurch within walking distance of the centre of the village and conveniently located for Crown Meadow First School, Alvechurch Church of England Middle School.

There are local bus service to Redditch and the surrounding areas and easy motorway access to Junction 2 of the M42 forming the hub of the midlands motorway network.

Set back from the road via a wide tarmacadam driveway and decorative front garden, a UPVC front door opens into the porch with further door into the lounge with staircase to the first floor accommodation and door into the modern kitchen diner with windows and door to the rear garden.

On the first floor landing there are doors to two bedrooms and modern shower room.

The rear garden has a paved patio area with shaped lawn and flower borders, timber shed, fencing to boundaries and gate side access to the driveway.

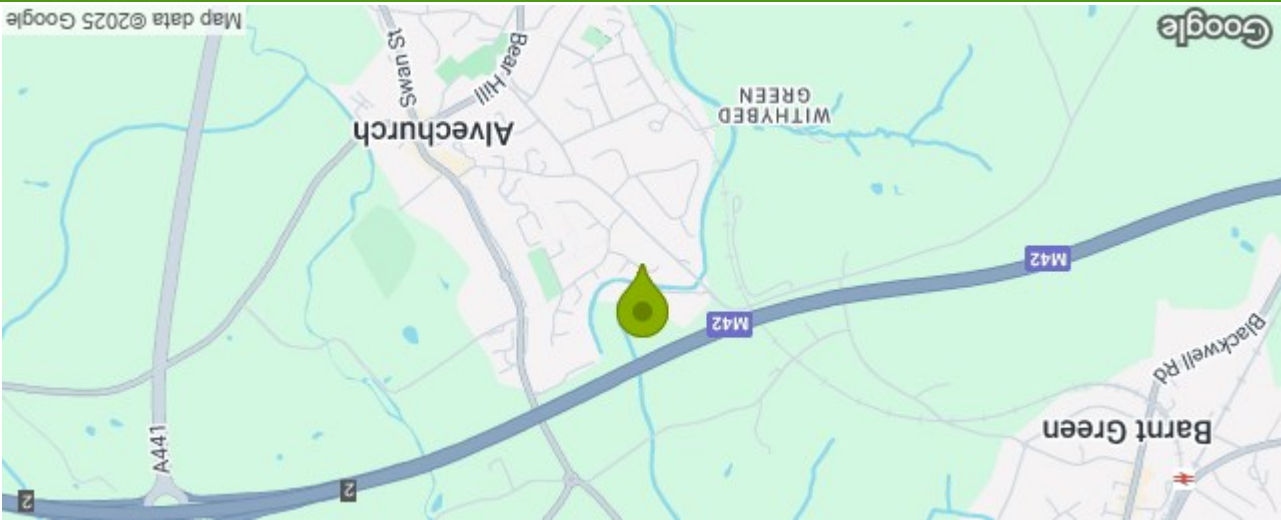

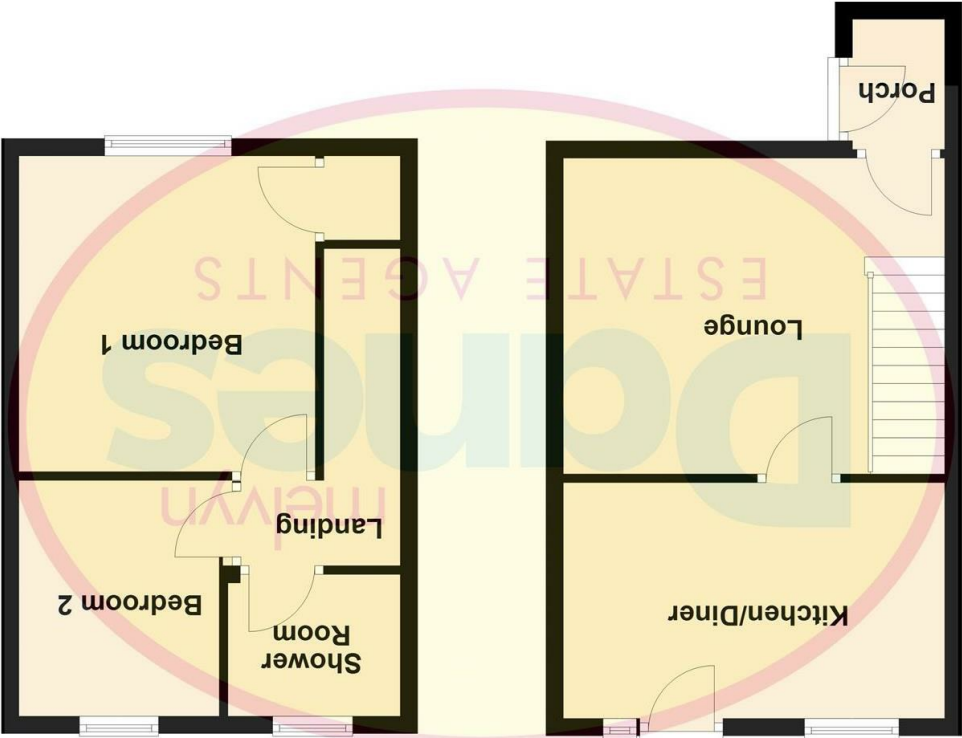

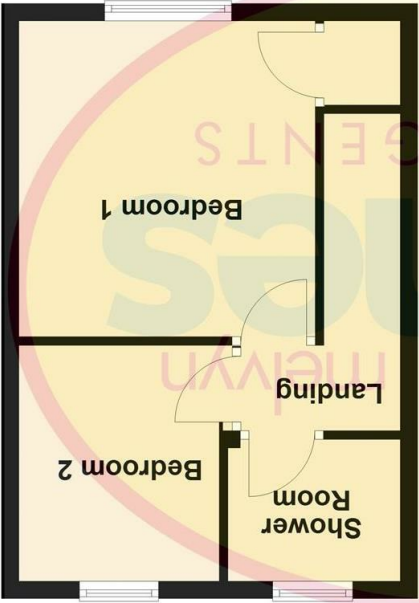
