The property is of a steel portal frame construction, providing accommodation across 3-principal bays. The elevations are of brick and blockwork with high-level glazing around the eaves. Consideration would be given to splitting the F & H to become independent units.

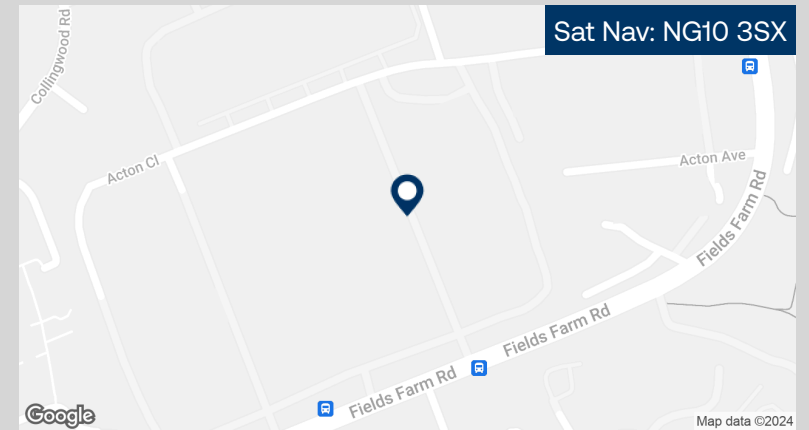
