Description

Unit G4 is a mid-terraced unit of steel frame construction with park brick, part profile metal clad elevations under a pitched roof. Two loading doors, 18ft (5.34m) eaves. There is parking to the front with dock loading and HGV parking to the rear. The unit is accessed via a personnel door to the front and it benefits from lighting throughout, a staff room and WC facilities. Services include 3 phase electricity supply, water and drainage.

Location

Lympne Distribution Park is a prime distribution location for hauliers and related trades who require good access to the motorway network, Channel Tunnel and ports. Located just 2.5 miles from junction 11 M20 it is also well placed to serve the immediate towns of Ashford, Folkestone, Canterbury and Dover.

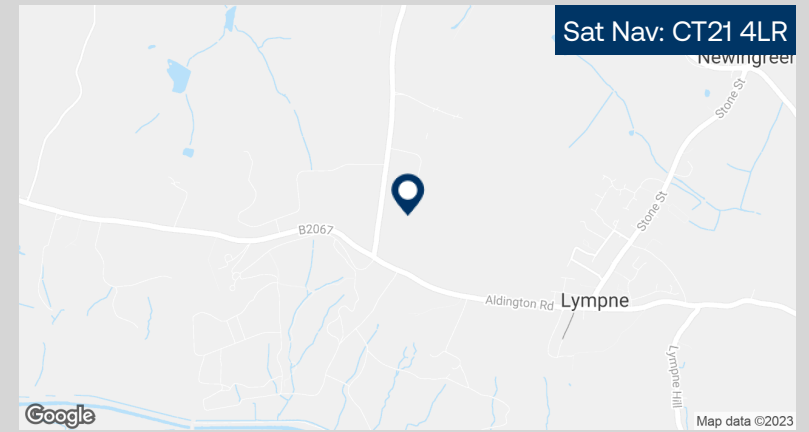
