## Location

Former Builders Merchant Stane Street, Westhampnett, Chichester, PO18 0NS

The property is situated on the southern side of Stane Street between the Chichester Recycling Centre and the Chichester Bypass roundabout. The city centre is approximately 1.5 miles to the south-west and the A27 is 0.6 miles to the south of the subject property providing easy access to the A259, M27 and wider motorway network.

The surrounding area comprises a mix of property uses, but predominantly residential. The Chichester Recycling Centre is to the rear of the subject property, with Chichester District Council Contract Services being in an office with yard immediately next door. Rolls Royce Motor Cars factory is located further east on Stane Street.

#### Description

The property comprises of large yard with three units – there is a single-story detached unit being used as a trade counter constructed of steel frame with brick and block lower elevations, and metal profile cladding (full height at the front and side of the unit, half height at the rear on the northern side).

The remaining two units are positioned as a semi-detached pair with a variance in height, constructed of steel frame, pre-cast concrete walls (rear and side elevations) and metal profile cladding.
