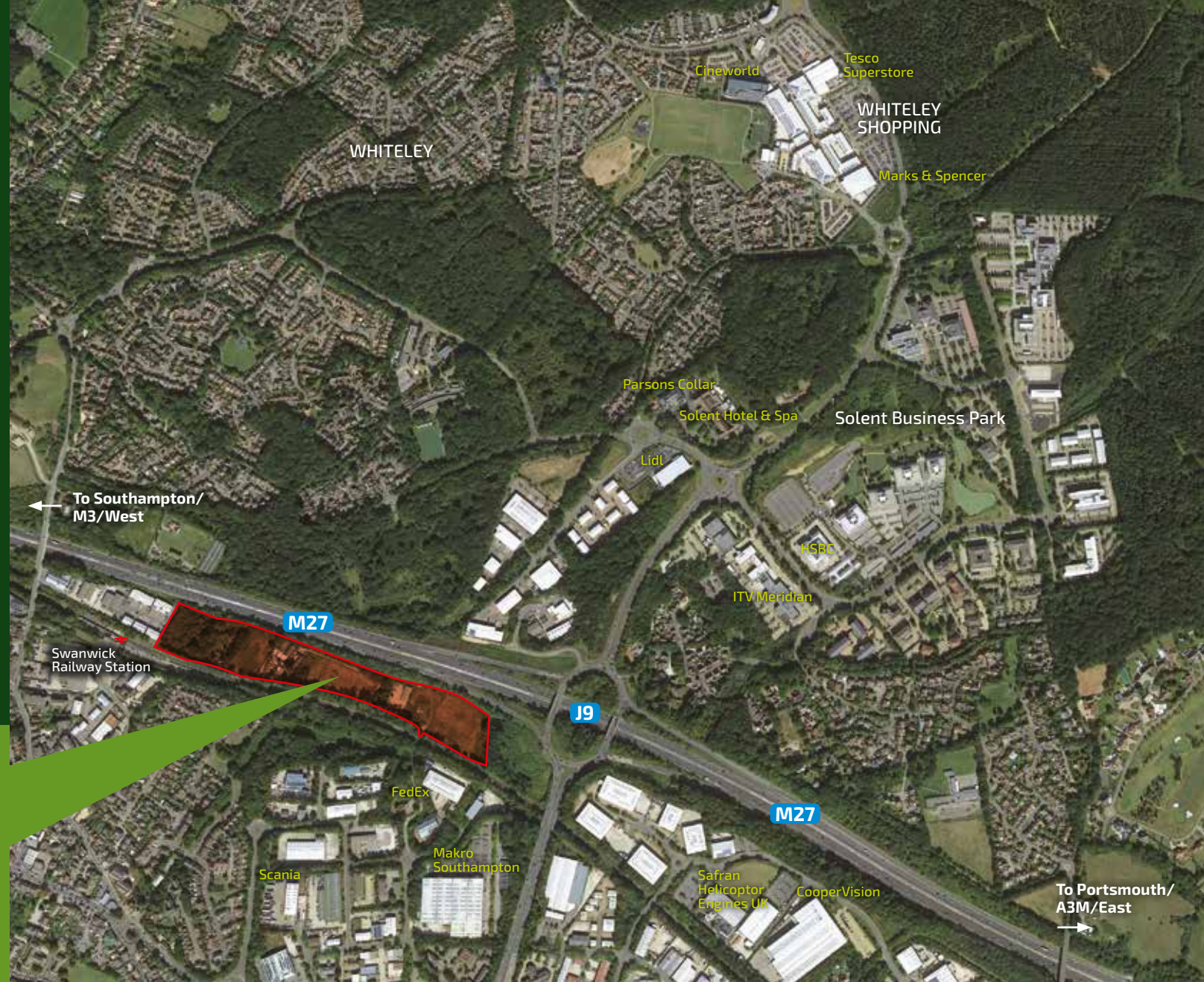

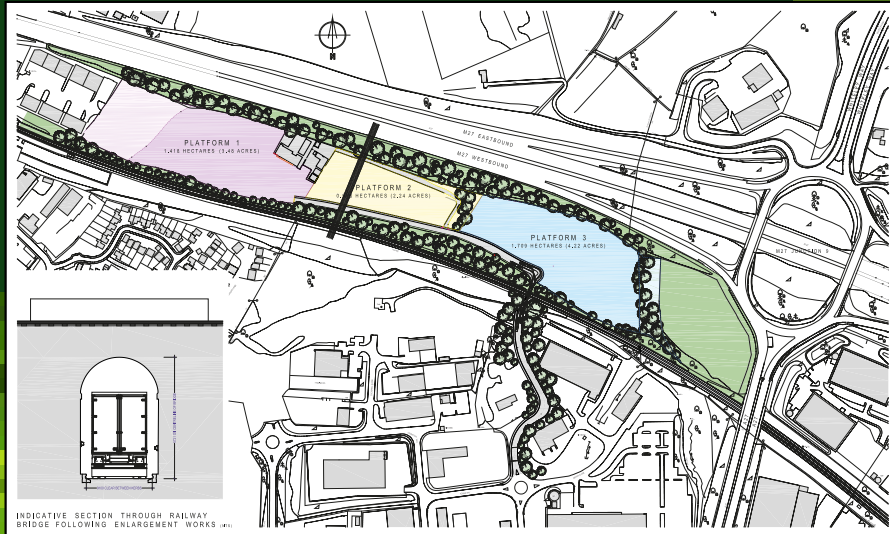

A small commercial vehicle workshop is included within the site and is currently on a short lease with a landlord redevelopment break option.



LOCATION

The site is located at the foot of Little Park Farm Road, which serves Segensworth West, and is accessed via a railway bridge, bordered by a railway line and the M27 motorway immediately west of Junction 9.

Segensworth is both a popular and established commercial location, providing immediate access to the M27 and A27 south coast road, strategically positioned between Southampton and Portsmouth.

The location is well served, with Whiteley Shopping Village to the north and Park Gate Village to the West. There are railway stations at nearby Swanwick and Fareham.

Occupiers in the vicinity include Makro, Scania, Safran Helicopters, CooperVision and TUV.

The site is zoned for employment uses under the Fareham Borough Council Local Plan.
