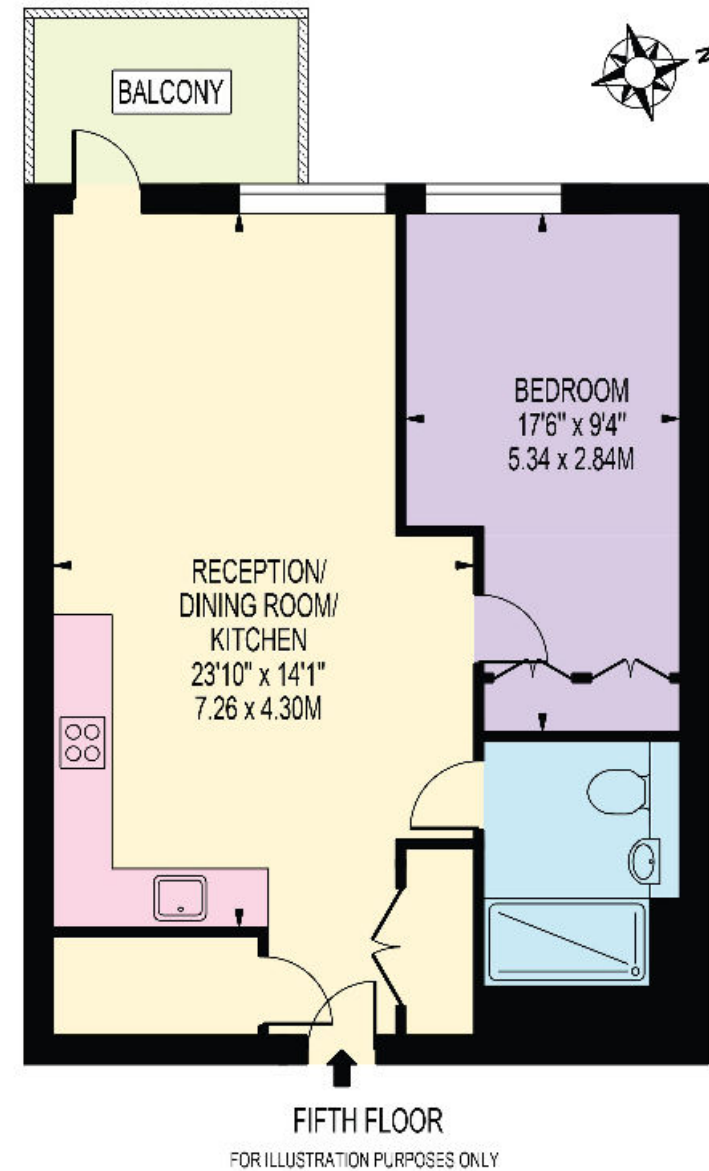
Chelsea Creek is well-located on the Thames Riverside. The green spaces of Imperial Park and Eel Brook Common are close by.
