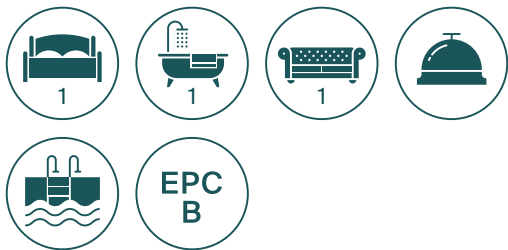


Lockside House, Chelsea SW6

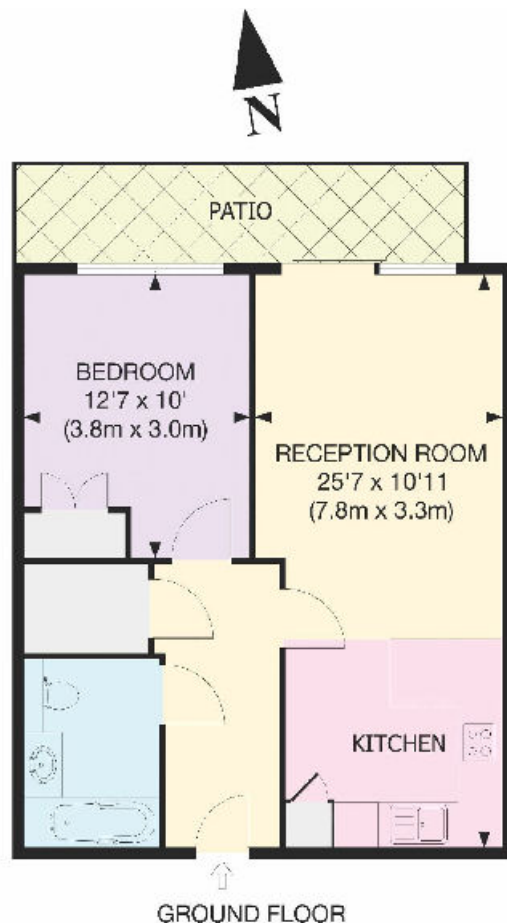
