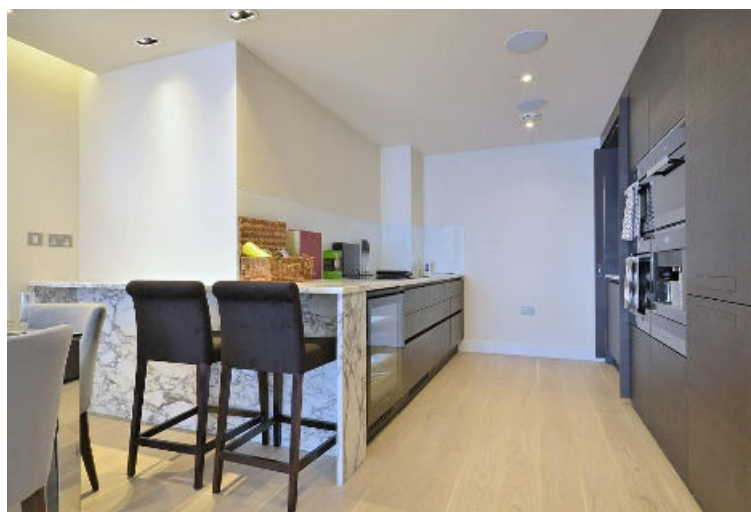
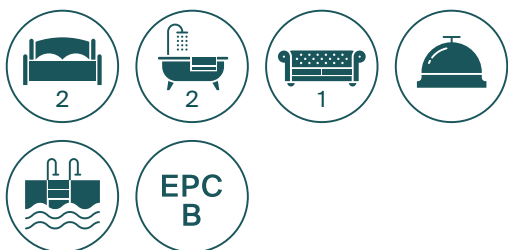


Countess House, Fulham SW6

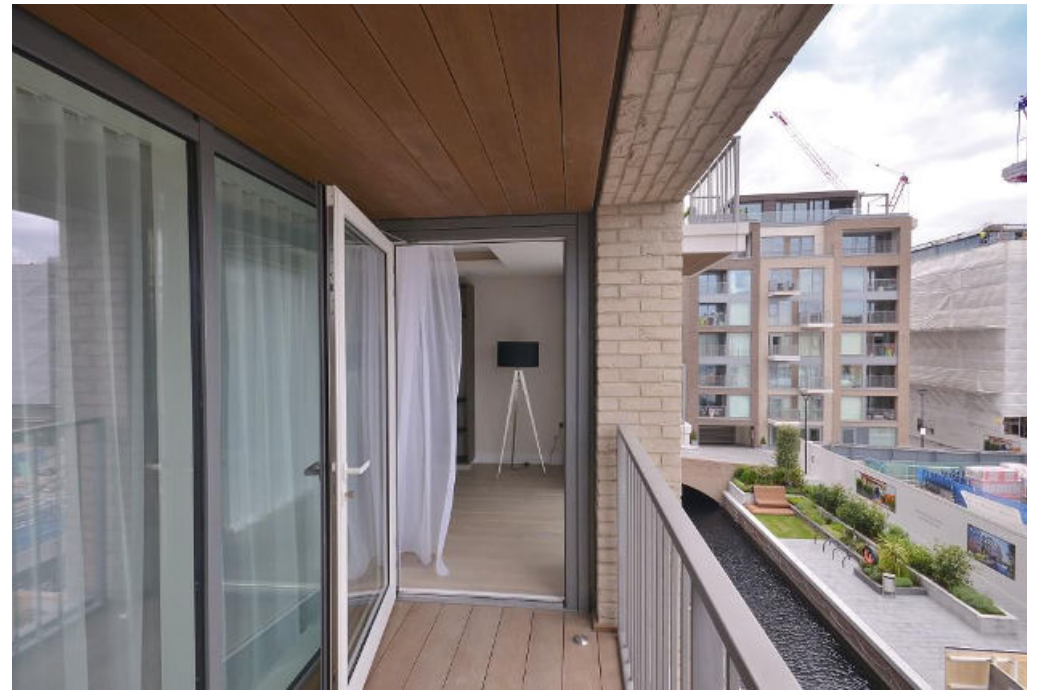
