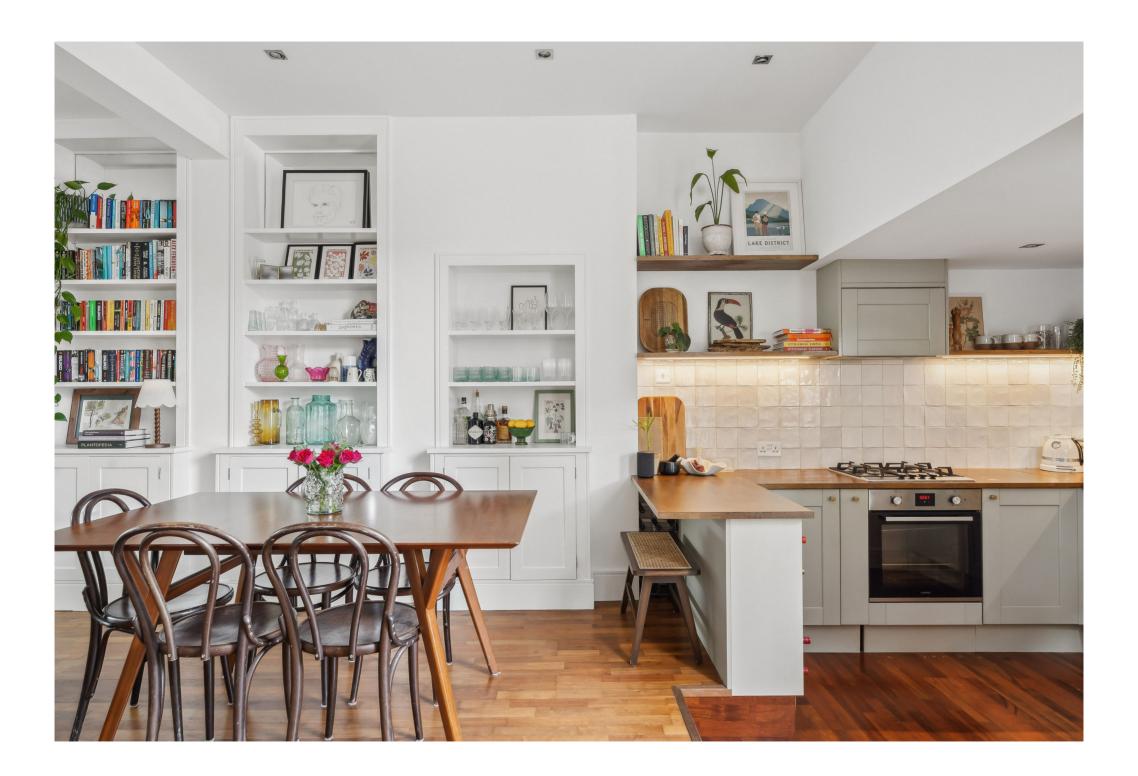


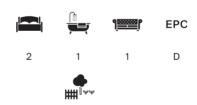

A pretty two-bedroom end of terrace cottage, located in a residential street close to Clapham Junction station and Northcote Road.

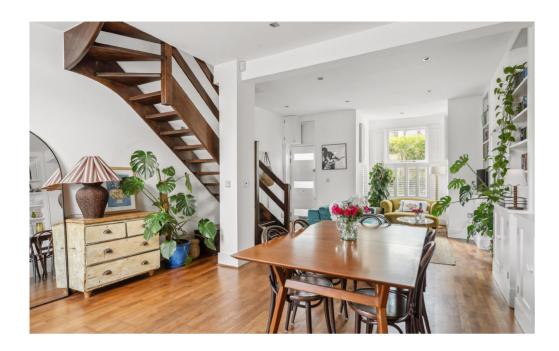

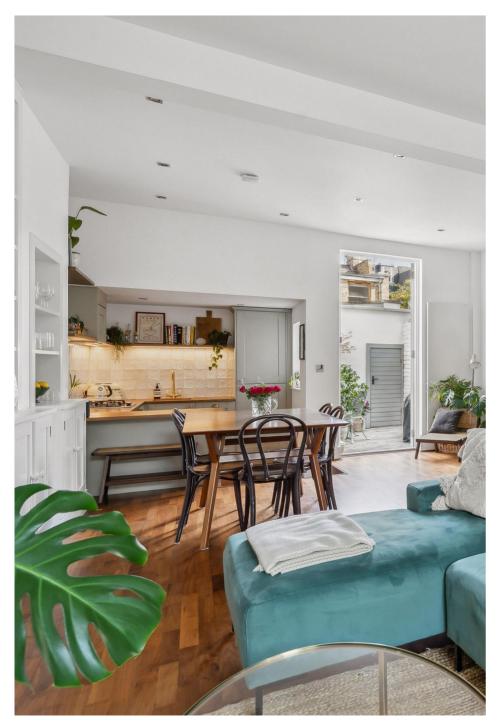
CHARMING, BRIGHT & PERFECTLY LOCATED

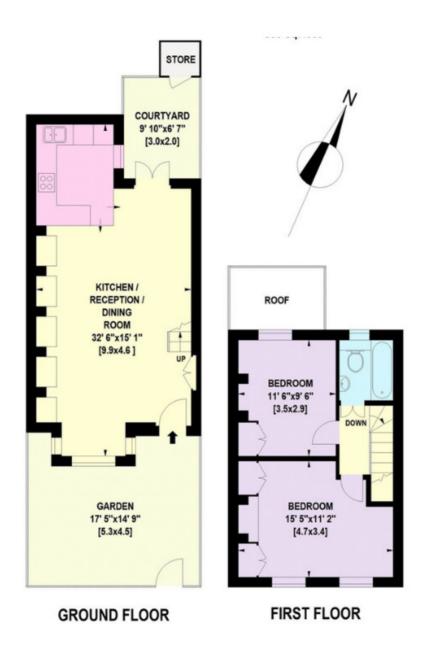
