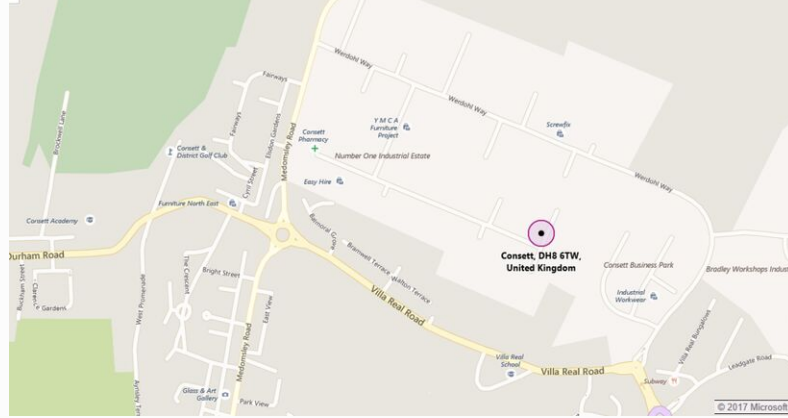
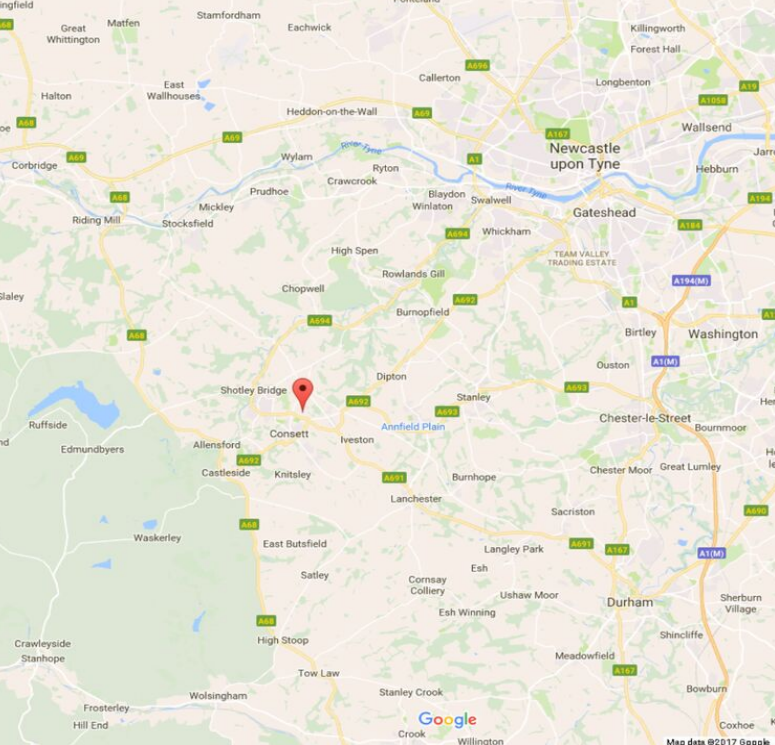

LOCATION

The estate can be accessed via the A691 or A692 and is approximately 3/4 mile north of Consett town centre. The estate is 13 miles from Durham City and is 9 miles from the A1/A692 junction at Team Valley.

Modern detached unit of steel framed construction with brick/blockwork and profiled metal cladding elevations. The insulated pitched roof is profiled metal sheeting with translucent panels providing natural light. The unit benefits from a reception area and offices to the front of the property. LED lighting is provided throughout.
