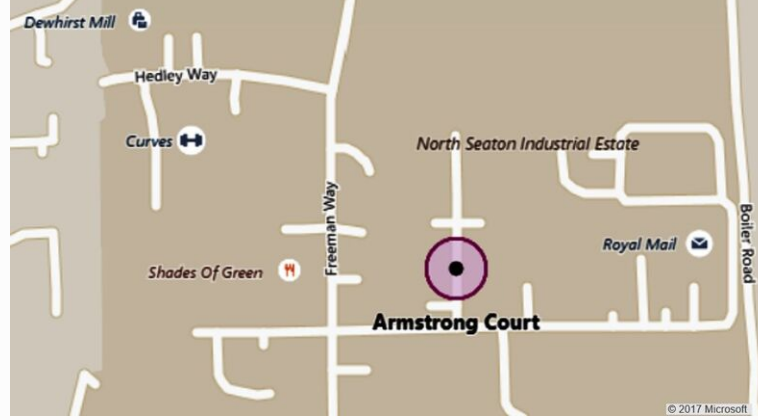
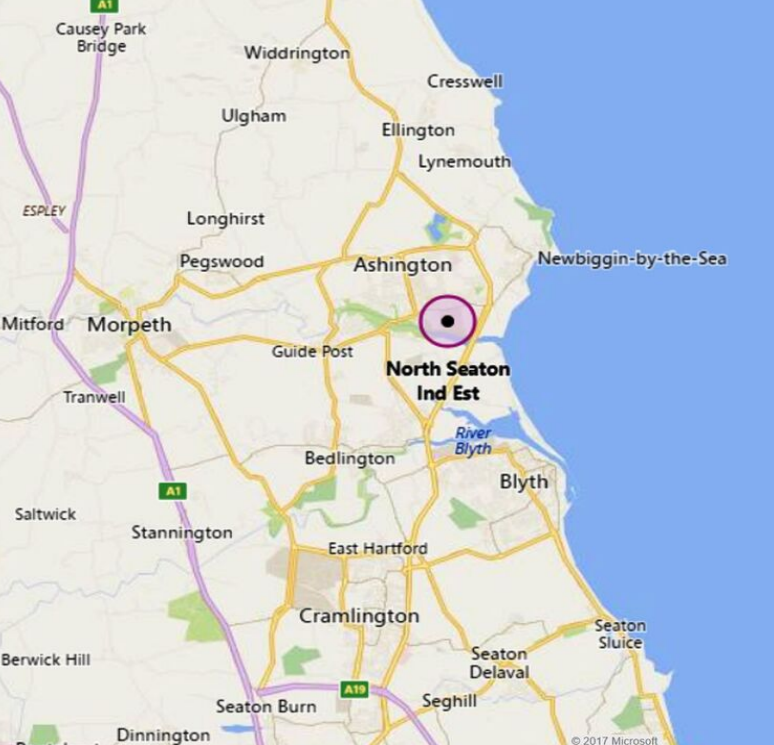

LOCATION

North Seaton Industrial Estate is located just off the B1344 road which links Ashington with the A189 spine road. The estate is approximately 16 miles north of Newcastle and has easy access to the A19 Tyne Tunnel route.

DESCRIPTION

Armstrong Court is made up of 5 blocks comprising 25 individual units ranging in size from 728 - 2,800 sq ft. The units are of steel frame construction with brickwork/blockwork walls and insulated metal cladding. The units have a separate personnel door and overhead sectional loading door.
