## **Property Description**

A fabulous four bedroom early-Victorian family home offering almost 2,000 sq ft of accommodation backing on to the Regent's Canal, on this highly sought after residential street in the heart of Angel.

Well presented throughout, and arranged over four floors, the property retains many of its period features including wooden floors, shutters and fireplaces which are complemented by more contemporary touches including a wonderful glazed rear addition on the lower ground floor. The house provides a wonderful double reception room on the ground floor, together with an open plan kitchen/dining area on the lower ground floor, flooded with natural light and opening on to a deep south facing garden. There is also a further less formal reception room on this floor, ideal as a playroom for children.

There are four bedrooms and two bathrooms on the upper two floors with a lovely open aspect across the canal from the top floor. Usefully there is also a further study to the rear of the raised ground floor.
