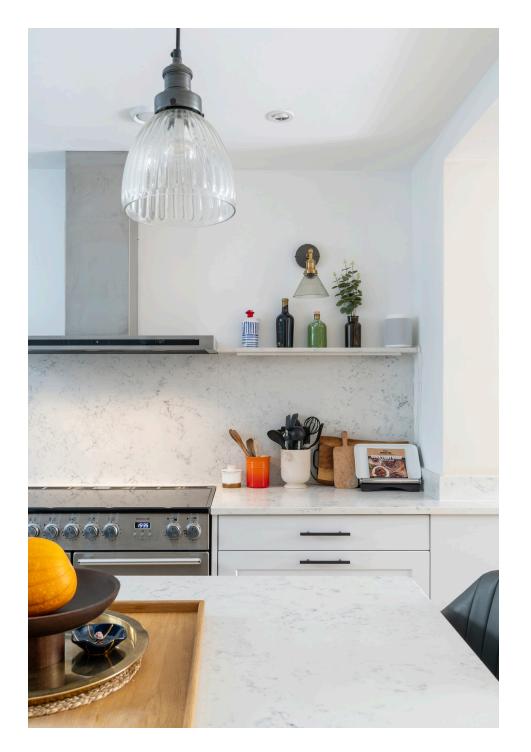

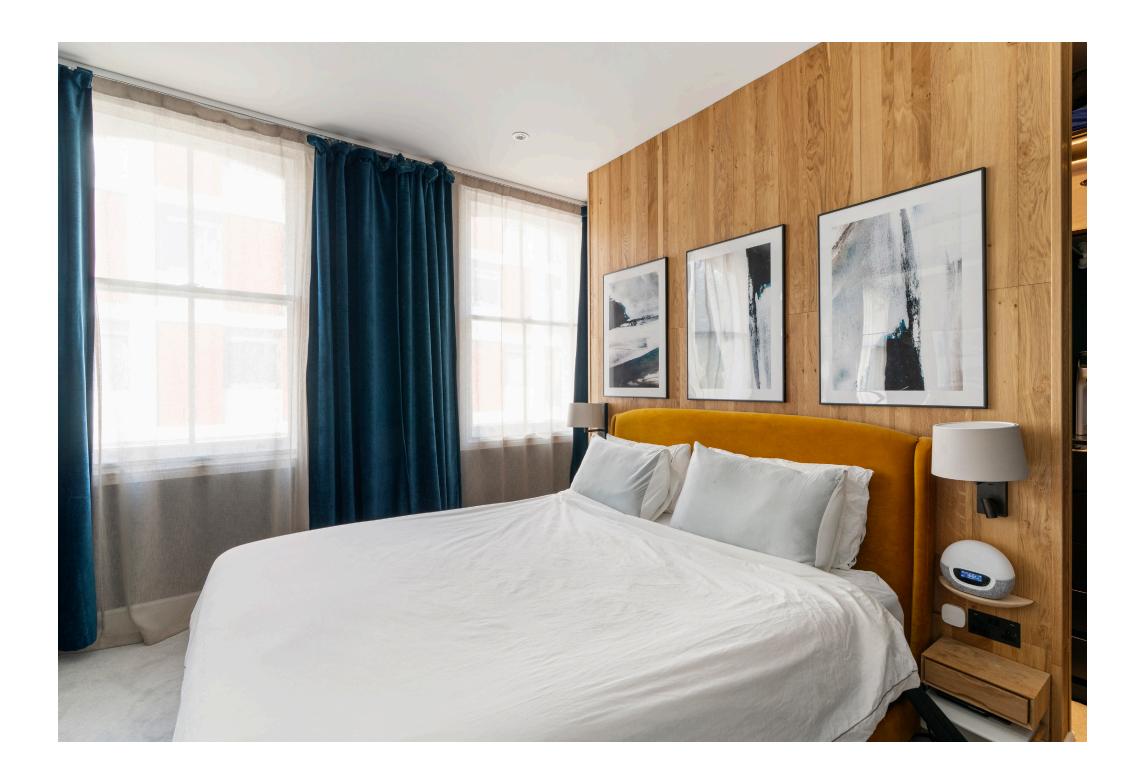


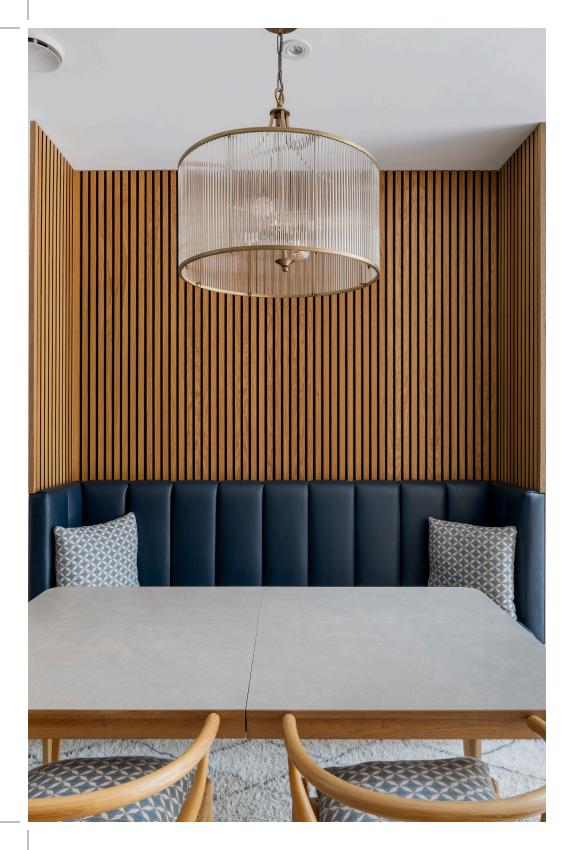

This floor also features a versatile single bedroom, ideal as a study, home gym, or nursery.

The lower ground floor is the true heart of the home — an expansive kitchen, dining, and living area that's perfect for both everyday life and entertaining. A generous kitchen island caters to culinary enthusiasts, complemented by quality integrated appliances.







The bespoke banquette dining area and additional living space, made possible by a full side return, create an impressive sense of width and openness. Sliding doors lead to a private patio with an electronic awning, stepping up to a well-kept lawn—a perfect setup for hosting and relaxing. This floor also includes a stylish WC and a uniquely designed laundry room, eleverly incorporated into the home's vaults.

On the first floor, you'll find two generously proportioned bedrooms and the main family bathroom. 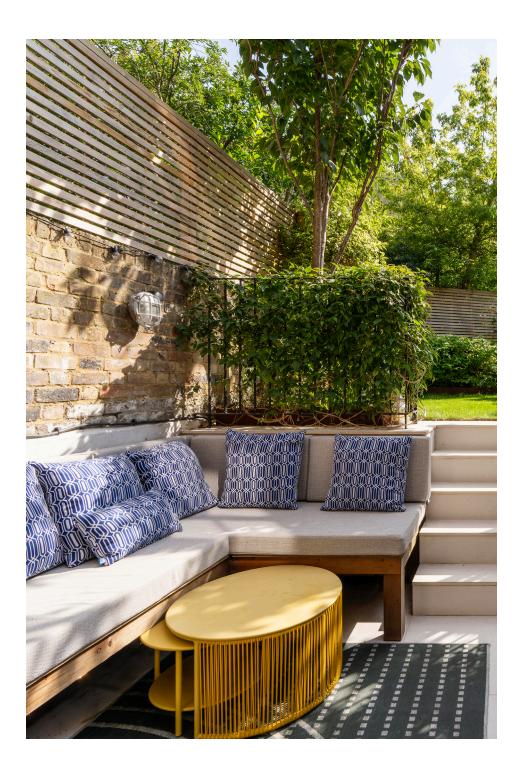
Further features include an advanced internal airflow system for year-round comfort and temperature balance and high-quality finishes throughout.

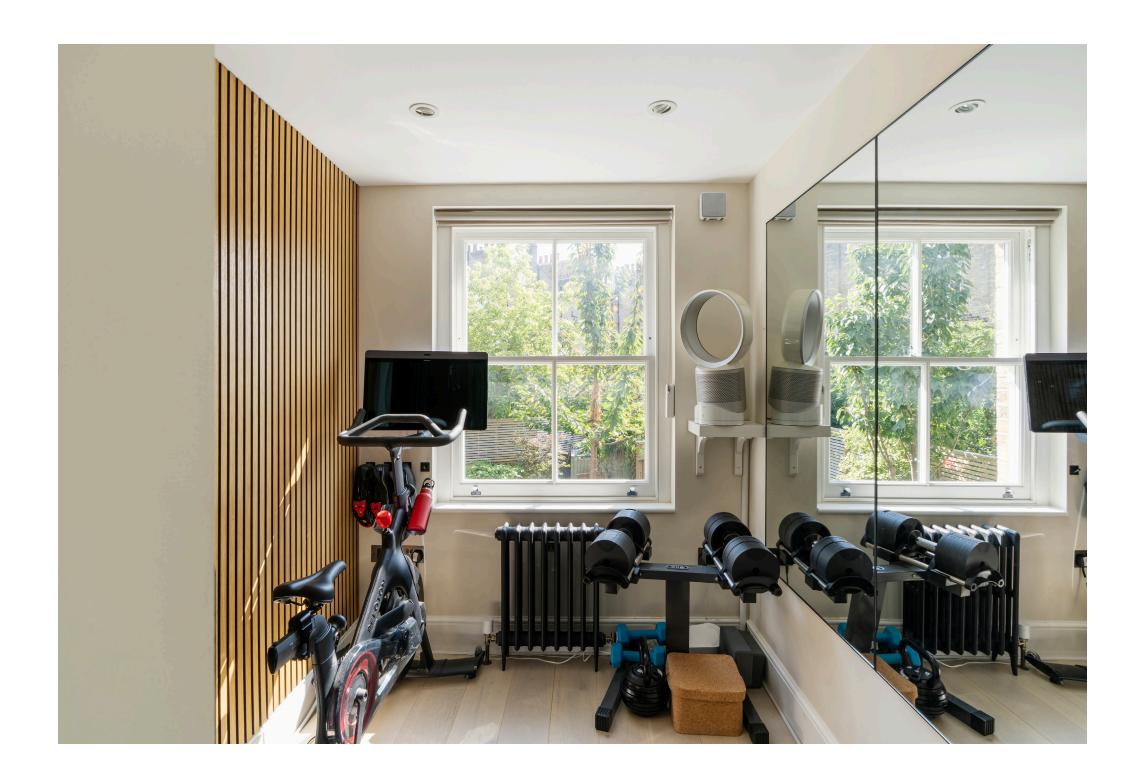


LOCATION
