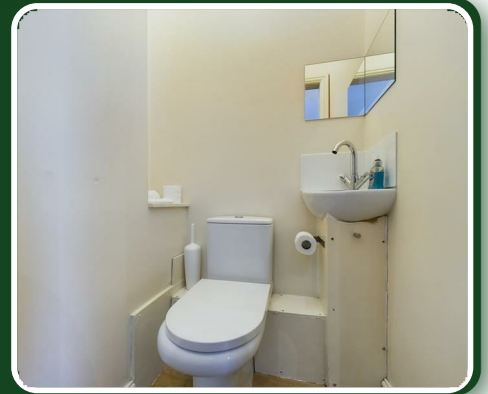

To the front of the property is a pebbled courtyard.

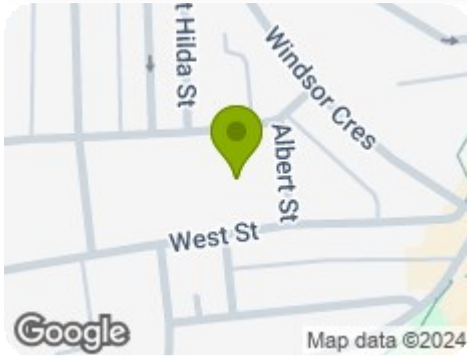

Terrain Map



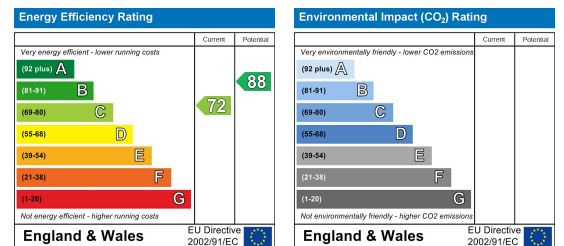
Floor Plan
