The property comprises: Communal entrance to staircase/lift to first floor, private entrance, modern kitchen, spacious lounge to outer decked balcony, a double bedroom and bathroom. Upvc double glazing and electric heating. No ongoing chain.

### **Communal entrance:**

Secure communal entrance with ground floor office/reception, staircase and lift facility to the first floor.

#### Private entrance:

Door into inner hall, built in storage cupboard and electric radiator.

#### Lounge/diner:

A spacious rear facing room, electric fire with a wood surround, electric radiator and upvc double glazed french doors onto the outer decked balcony.

A rear facing double room, built in storage cupboard housing hot water store, upvc double glazed window and electric radiator.

#### **Bathroom:**

Comprises bath with shower attachment, shower cubicle with plumbed in shower, wc and wash hand basin. Full wall tiled, floor tiled, extractor, shaver socket and electric towel radiator.

#### **Exterior:**

Communal grounds with small garden area. There is a side access leading straight onto the sea front. Concealed waste and refuse area. Non-designated residents parking.

Leasehold 999 year lease. Current ground rent £62.00 a quarter & Service charge £505.88 a quarter.

This charge covers communal area's cleaned, maintained,





heating and lighting to those areas, part time scheme manager, building insurance, window cleaning (external) cctv. Residents communal lounge plus kitchen, car park, maintenance and lift maintenance etc.

There is also a reserve fund/sinking fund which is money put aside to deal with planned maintenance. By building up a reserve they are able to fund major works when required without having to collect necessary funds from individual residents. It also means that owners are less likely to receive large unexpected bills.

There is a communal lounge for the residents where activities including coffee mornings and games evenings are regular for all the residents.

There is a full security system and smoke alarm.











#### Floor Plan
