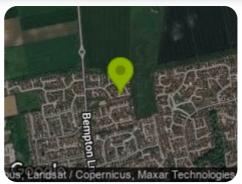






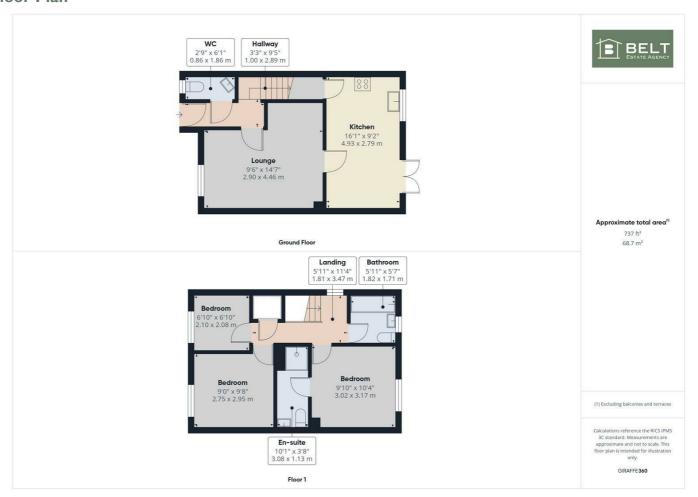








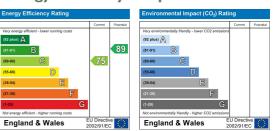
Floor Plan
