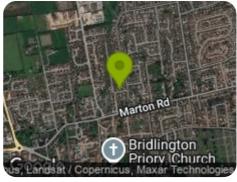






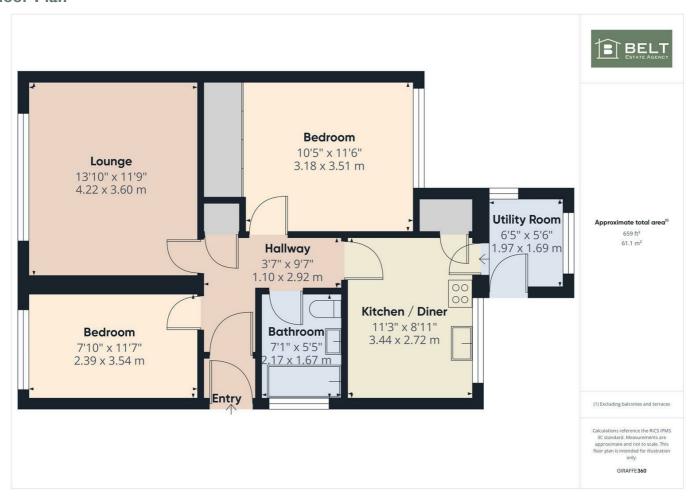








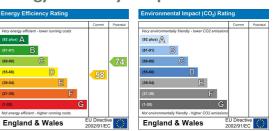
Floor Plan
