Location

The site is situated immediately adjacent to the mainline railway track, to the north east of Leicester's main railway station, within an industrial area on the western periphery of Highfields in Leicester. The site is accessed via Humberstone Road (A47) via Kent Street which links in with Murray Street and Beal Street. The site has the benefit of being in close proximity to Leicester's main shopping centre some 3/4 of a mile to the east of the city centre. The main A47 links in with Leicester's inner ring road system which provides direct access around the city centre and further connects to the motorway networks, J21 of the M1/M69.

Description

The site comprises a fairly regular rectangular shaped, level site, that is securely gated and fenced with tarmacadam, concrete and granite surfaces. The site benefits from a return frontage, albeit the current access onto the site is shared.


