Location

The property is located in Leicester, within the suburb of Oadby. Leicester is the second largest city within the East Midlands located some 20 miles south of Nottingham and 43 miles north-east of Birmingham.

Oadby itself is a popular satellite area of the city, lying approximately 4 miles to the south-east of the City centre. Oadby is primarily a residential dormitory area, though is supported by its own shopping centre along The Parade together with Asda, Sainsburys and Lidl Supermarkets nearby. The property lies on the east side of The Parade close to the corner with South Street, which links in with the main public car park to the rear of the site. This section of The Parade incorporates predominantly local convenants, however, there are a number of national retailers that include Marks and Spencer Food, Costa Coffee, Boots and Holland and Barratt.

Description

The property comprises a self contained ground floor retail premises which has been arranged to provide flexible sales accommodation to the front of the unit, with a store room, kitchen, and WC to the rear. The property has been fitted out to a high specification throughout.

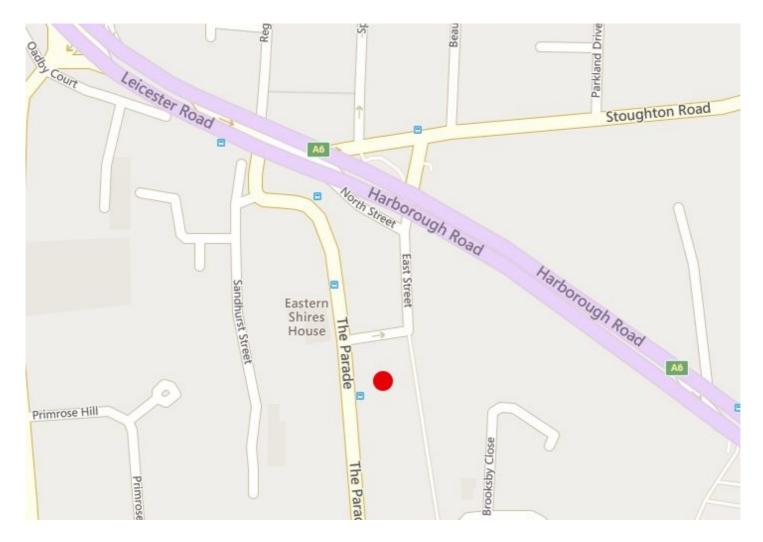

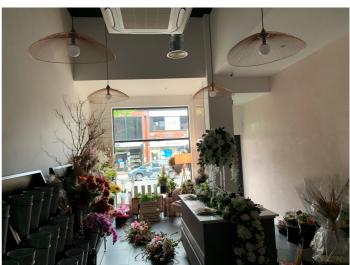
