Location

Hinckley is a thriving market town with a large commercial centre located some ten miles west of Leicester and three miles from Nuneaton. Florence House is located within the heart of the town centre on St Mary's Road within walking distance of the main shopping thoroughfares. There is swift access out of the town to the A5 and M69 Motorways.

Description

A highly prominent self-contained and attractive office building that is constructed over three levels in brickwork, under a pitched tile roof. The suite, which is situated on the ground floor, generally provides clear open plan accommodation but has been subdivided in part with demountable partitioning to create a number of offices together with a small kitchenette.

There is a shared entrance lobby and WCs at ground floor level.

To the rear of the building is a secure car park, providing parking for 4 cars. There is a Local Authority 'pay and display' car park directly opposite.
