Location

The premises are situated in Castle Donington on the Trent Lane Industrial Estate, a well established strategic storage and distribution location with excellent proximity to the A50 and M1 J24/J23a and A42/M42 network.

Description

A three bay warehouse of steel portal frame construction with part brick and profile clad elevations under pitched profile clad roofs with translucent light panels.

The unit benefit from ground level access loading doors, high level fluourescent and sodium lighting, w.c. accommodation.

Constructed to an internal clear eaves height of 4.3m.

Externally there is a large yard and circulation space.


