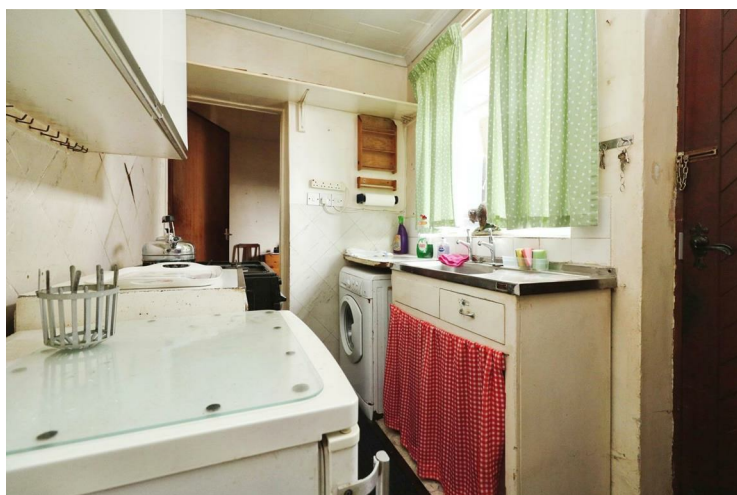

Buyers will be required to go through an identification verification process with iamsold and provide proof of how the purchase would be funded.

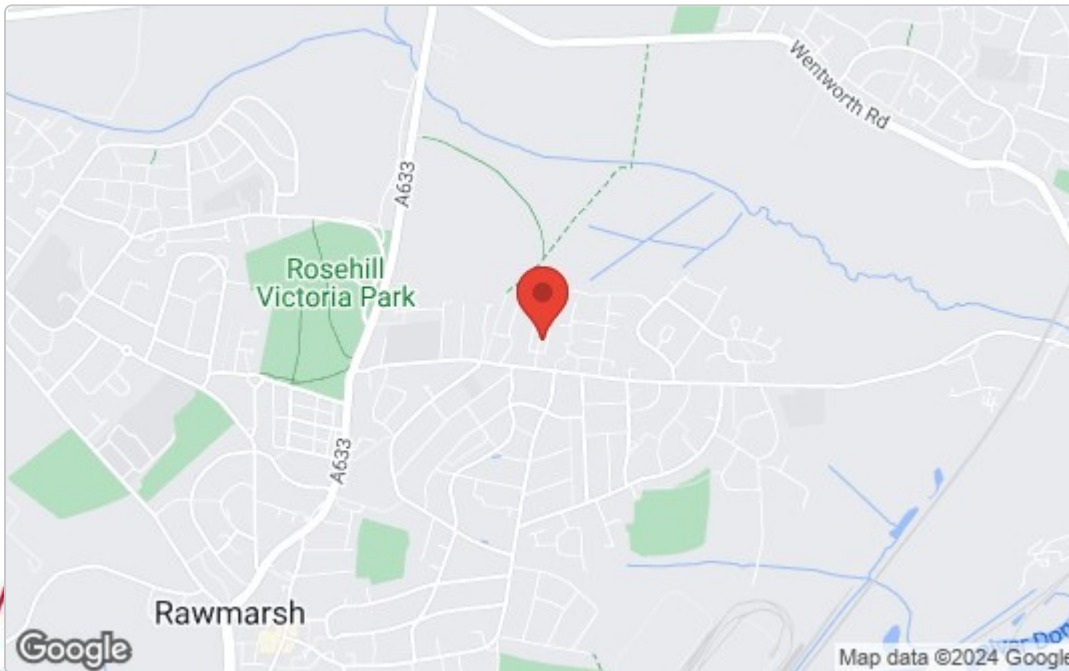

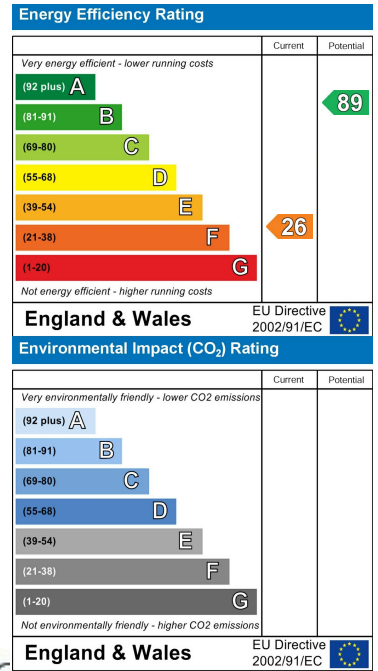
# Floor Plan
