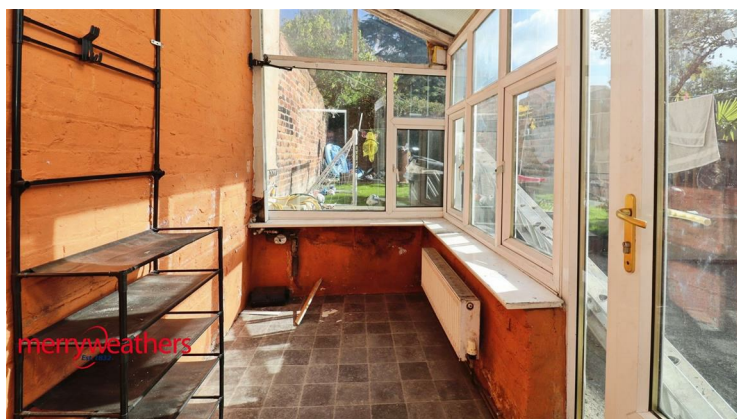

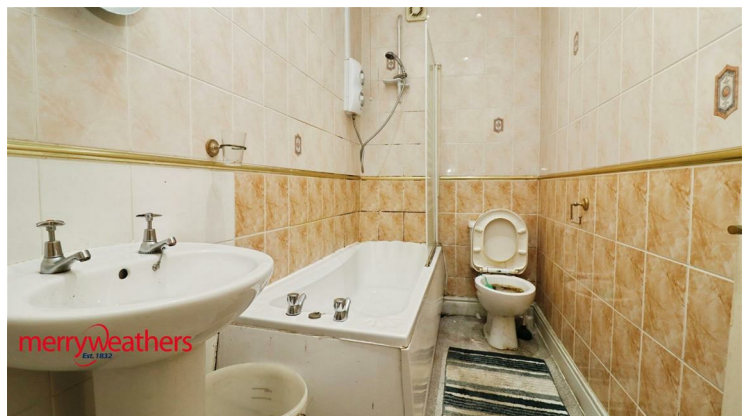

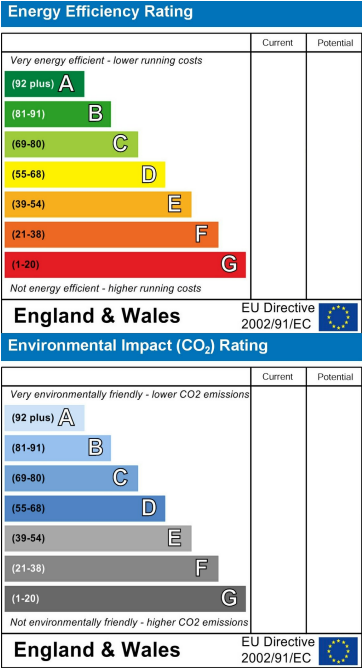
Floor Plan
