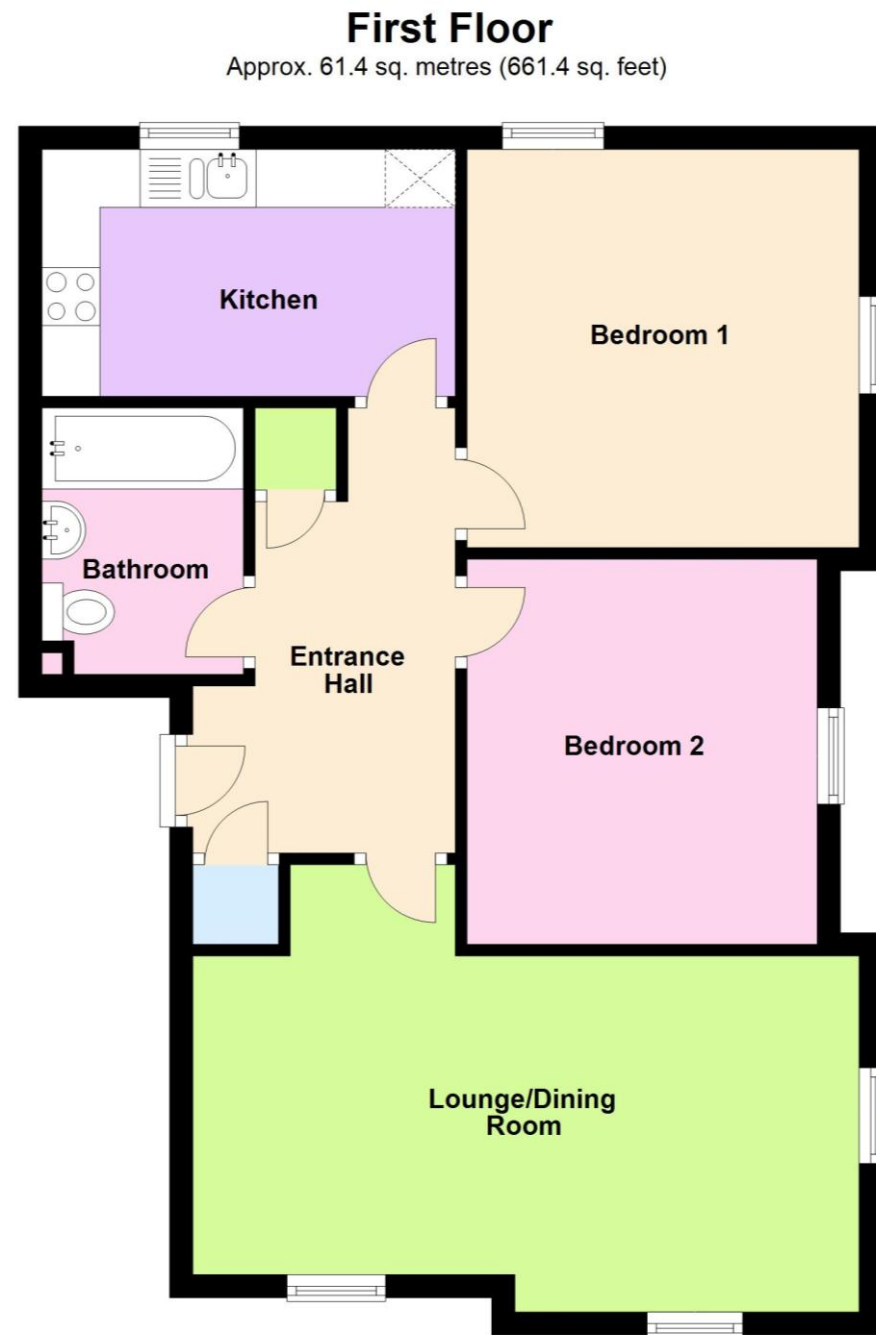

The accommodation briefly comprises entrance hall, lounge/dining room, kitchen, two bedrooms, bathroom and an allocated parking space.**
