Offered with no chain is this extended three bedroom end of terrace property which is within walking distance of the town centre. The property benefits from uPVC double glazed doors and windows, gas radiator central heating, a 19ft refitted kitchen with built in appliances to include oven, hob and dishwasher and further offers a 25ft lounge/dining room and the addition of a downstairs shower room. The accommodation briefly comprises porch, entrance hall, lounge/dining room, kitchen, downstairs shower room, three bedrooms, upstairs shower room/wet room and courtyard gardens to front and rear

Rear - Courtyard garden, shed, enclosed by fencing, gated pedestrian access to side.

Front - Gated access, enclosed by brick wall, laid to paving.
