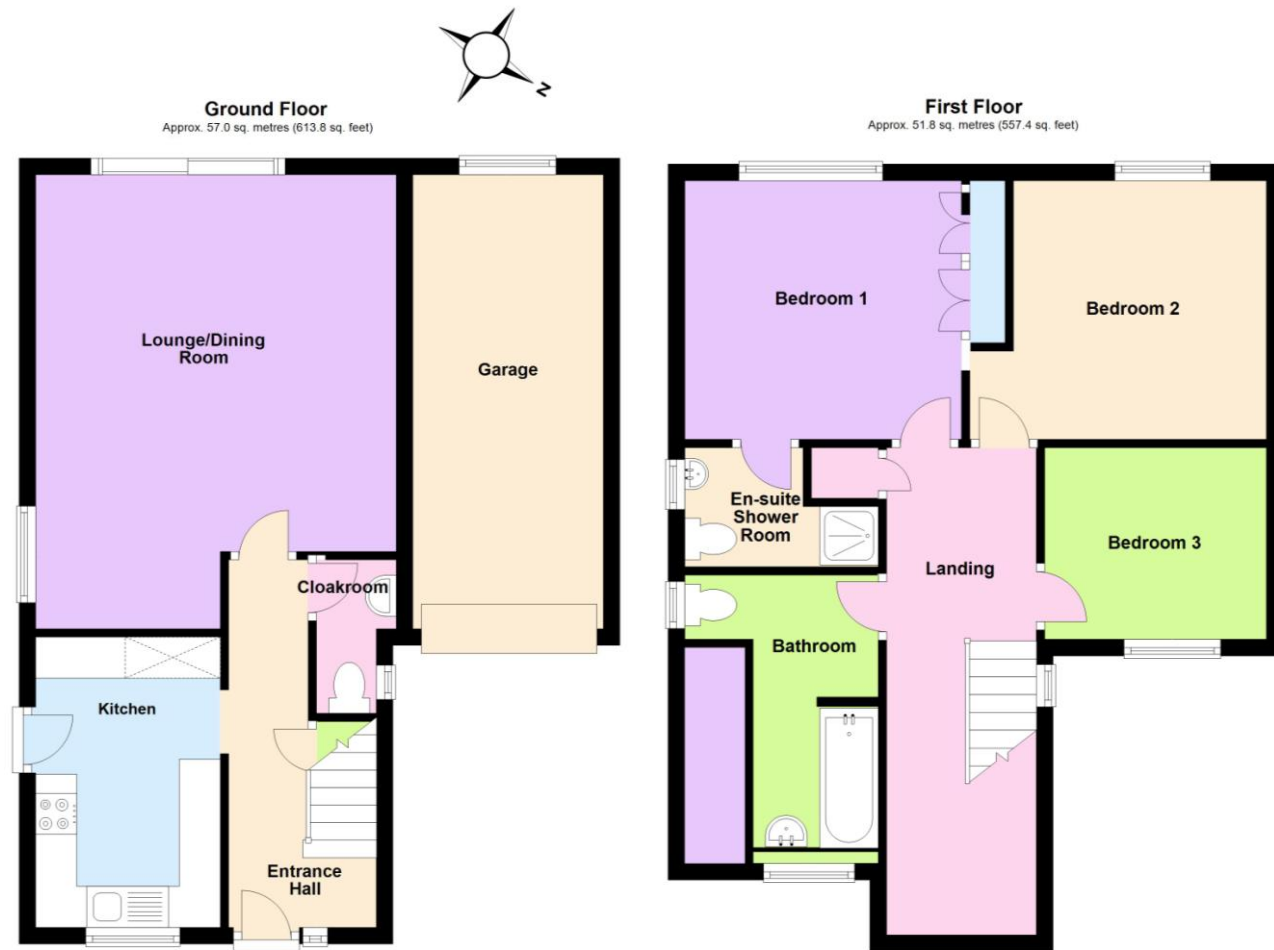

The property benefits from uPVC double glazing, gas radiator central heating, a refitted kitchen with a range of built in appliances and a refitted cloakroom and ensuite shower room. The accommodation briefly comprises entrance hall, cloakroom, lounge/dining room, kitchen, master bedroom with ensuite shower room, two further bedrooms, bathroom, gardens to front and rear and a garage.**

#### **Cloakroom**

Refitted white suite comprising low flush W.C., wash basin with vanity cupboard under, grey radiator, obscure glazed window to side aspect.

#### **Lounge/Dining Room**

18' 1" narrowing to 14' 10" x 14' 6" (5.51m x 4.42m)
