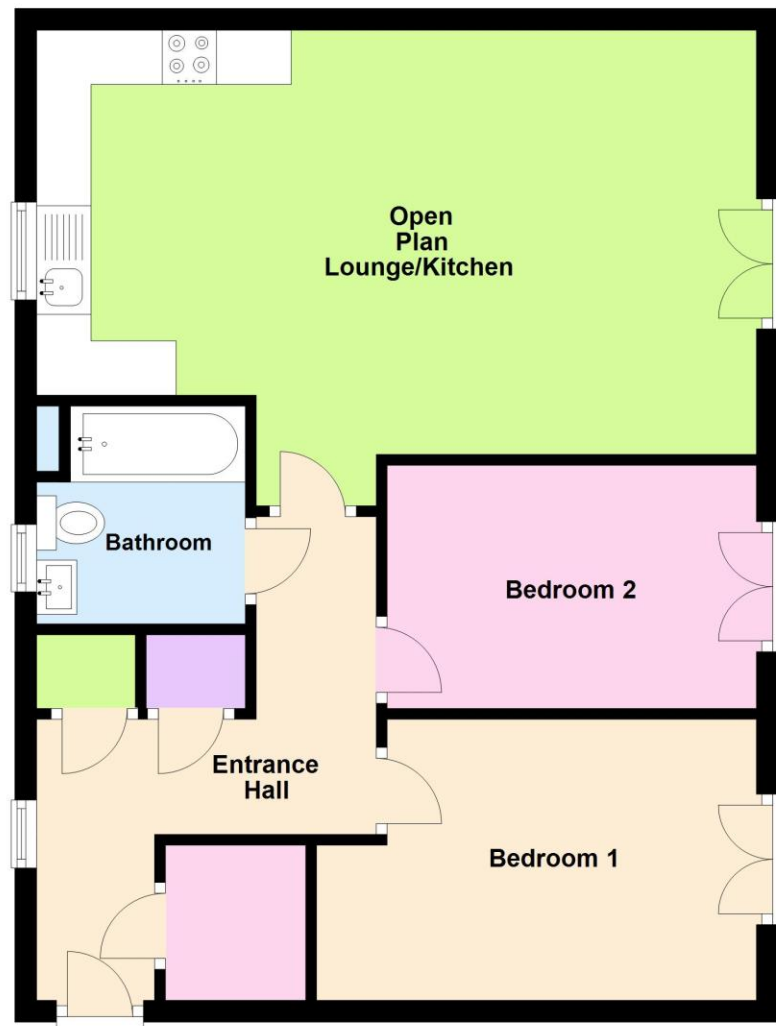

Situated within walking distance of the Railway Station, Station Cross park and primary school is this two bedroom first floor flat built by Bovis Homes in 2021. The property benefits from uPVC double glazing, gas radiator central heating, built in kitchen appliances to include oven, hob, dishwasher and washing machine and further offers a 21ft open plan lounge/kitchen, an allocated parking space and a garage. The accommodation briefly comprises entrance hall, open plan lounge/kitchen, two bedrooms, bathroom, an allocated parking space and a garage.
