Offered in excellent condition throughout is this three bedroom semi detached property which benefits from a refitted kitchen with built in appliances, a refitted bathroom, uPVC double glazed doors and windows, gas radiator central heating, built in wardrobes to bedroom one and loft & cavity wall insulation. The property further offers a rear garden measuring approx. 51ft max in length and off road parking for two vehicles. Viewing is highly recommended. The accommodation briefly comprises entrance hall, lounge, dining room, kitchen, three bedrooms, bathroom, gardens to front and rear and off road parking.
