



Offered with no chain is this superbly presented three bedroom terrace house situated in the centre of the village local to main amenities. The property benefits from uPVC double glazing, gas radiator central heating, a refitted kitchen with a range of built in appliances, a refitted bathroom suite and a replacement roof in 2024. The rear garden measures 47ft and extends to 63ft overall. The accommodation briefly comprises entrance hal, lounge/dining room, kitchen/breakfast room, three bedrooms, bathroom and gardens to front and rear.
