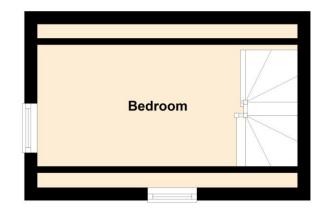

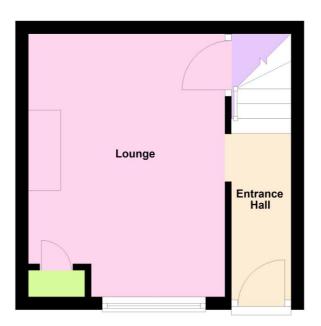
Second Floor
