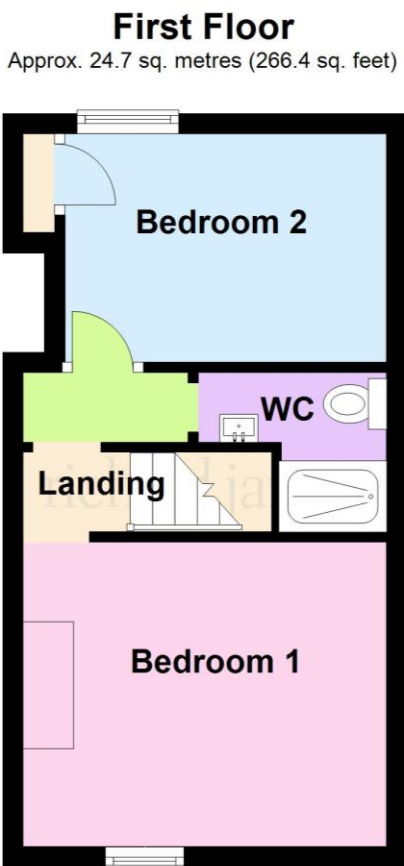
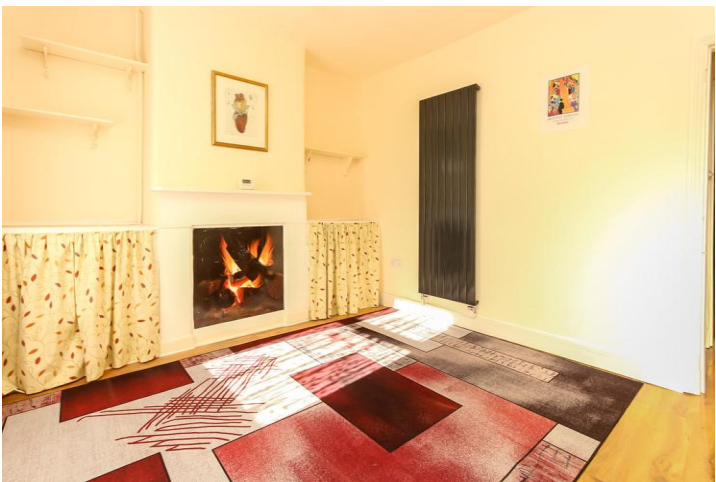

Ideal for the first time buyer or investor and situated local to the railway station and town is this vacant two bedroom terrace which has been modernised and now benefits from a refitted kitchen with built in appliances, a refitted shower room, uPVC double glazed doors and windows and gas radiator central heating. The property further offers separate reception rooms and newly laid flooring. The accommodation briefly comprises lounge, inner hallway, dining room, kitchen, shower room, two bedrooms and garden to front and rear.
