

Situated in a cul de sac within walking distance of schools and the town centre is this two bedroom terrace property which would make an ideal purchase for a first time buyer or buy to let investor. The property benefits from uPVC double glazing, gas radiator central heating, uPVC facias, soffits and guttering and built in kitchen appliances and further offers two well proportioned bedrooms and two off road parking spaces. The accommodation briefly comprises entrance hall, lounge, kitchen/breakfast room, two bedrooms, bathroom, garden to rear and off road parking.
