

Offered to the market with no upward chain is this well presented Bloor constructed three bedroomed semi detached property featuring built in kitchen appliances, gas radiator central heating, uPVC double glazing and offers allocated off road parking for two cars and en suite shower room to the master bedroom with fitted wardrobe. The accommodation briefly comprises entrance hall, lounge, kitchen/dining room, utility area, cloakroom, three bedrooms with en suite shower room to master, bathroom, front and rear gardens and allocated off road parking.
