

Constructed in 2019 is this very well presented three bedroomed semi detached property featuring a generous 19ft x 10ft kitchen/dining room and off road parking for two cars. Further benefits include gas radiator central heating, uPVC double glazing, built in kitchen appliances and offers fitted wardrobes/en suite shower room to the master bedroom and well presented gardens. The accommodation briefly comprises entrance hall, cloakroom, lounge, kitchen/dining room, three bedrooms with en suite shower room to master, bathroom, front and rear gardens and off road parking for two cars.
