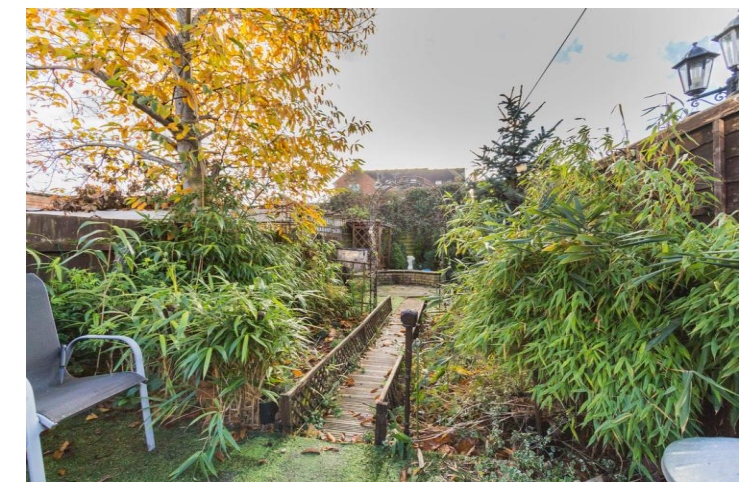

Offered with no upward chain is this mature bay fronted two bed roomed mid terraced property featuring approx. 956 square feet of accommodation with features to include gas radiator central heating and majority uPVC double glazed windows however please note the property is in need of some updating and redecoration. The property further offers a 25ft lounge/dining room, two double bedrooms and a 60ft rear garden. The accommodation briefly comprises porch, entrance hall, lounge/dining room, kitchen, lean-to, potential utility/storage (former bathroom), separate W.C., two double bedrooms, bathroom, front and rear gardens.

Garden measures approximately 60ft in length.
